Special Note on products containing Brass

We do supply some products with brass inserts. Typically, the insert weighs approximately 8g per item. In order to render brass machinable, lead is added at a concentration of 2 to 3% W/W.

In the form supplied, lead is not released from the product in any foreseeable form of usage. We believe therefore that these products comply with the low release rate derogation. Rencol is not required to register these products because of the low quantity derogation.

The total quantity of lead we export in this form to the EU in any one year is less than 70kg.
